Simply complete the application below and mail, email, fax, or return it to us in person.

A few things to note...

A processing fee of \$35.00 per loan will be deducted from your account.

A loan must be outstanding for six (6) months with all on-time payments before the loan is eligible for the program.

Members are eligible for two (2) skips in a year per loan.

Real Estate Loans (ie Home Equity Lines of Credit and Home Equity Loans, etc.) are not applicable.

Members are not eligible for the Skip-A-Pay Program if:

- · The Loan(s) is **PAST DUE** at the time of the request.
- · The Member has a Loan Workout on their account.
- · The Member has already had two Loan Extensions.
- · The Member is overdrawn on his/her checking account for more than 30 days

Applications must be received at least four (4) business days prior to the loan due date.

Approval is required for all skipped payments.

Restrictions and eligibility requirements may apply due to PSFCU's COVID-19 Forebearance Program.
